

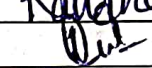
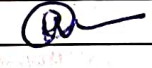
Grievance Redressal Report: Vijay Memorial College of Education, Barsu Bagla

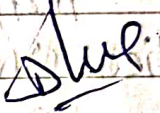
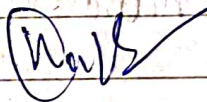
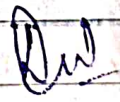

- School facility should be provided in native places for Teaching practice for those students who have their personal issues.



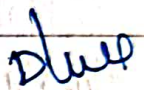
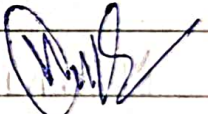
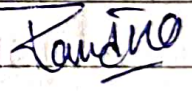
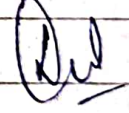
